AN ORDINANCE AMENDING CHAPTER 284 OF THE CODE OF THE CITY OF BRIGANTINE AS IT RELATES TO HANDICAP PARKING SPACES

WHEREAS, State statute specifically allows municipalities to establish restrictive parking zones in front of residences occupied by handicap persons; and

WHEREAS, a request has been made to the City of Brigantine concerning two such handicap parking spaces; and

WHEREAS, implementing this Ordinance would be a benefit to the health, welfare and safety of the residents of the City of Brigantine and the individuals who need the use of said handicap spaces; and

WHEREAS, the spaces set forth in this Ordinance have been investigated by the Brigantine Police department who have recommended the same.

NOW, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BRIGANTINE IN THE COUNTY OF ATLANTIC AND STATE OF NEW JERSEY AS FOLLOWS:

SECTION I: Section 284-59 of the Code of the City of Brigantine shall be amended be adding the following spaces as a designated handicap spaces within the City of Brigantine:

NAME OF STREET 121 31st Street Sotuh

LOCATION

Twenty (20) foot area on the side of the property located at 121 31st Street South

SECTION II: Upon adoption by the City Council of the City of Brigantine of this Ordinance, the Department of Public Works and all other appropriate entities area authorized to take any and all steps to erect the appropriate signs designating the above spaces as a handicap parking spaces and to take any other action to fulfill the intention of this Ordinance.

SECTION III: Severability

If any section or part of this Ordinance is deemed to be invalid or illegal in any court or competent jurisdiction then said part is severable from this Ordinance as a whole and the remaining selections or parts of this Ordinance shall remain in full force and effect.

<u>Section 1</u>. The following fees are hereby established:

 - C. Effective Date. This Ordinance shall take effect upon proper passage in accordance with the law.

ORDINANCE NO. 19 of 2020

"AN ORDINANCE PROVIDING FOR RESTRICTED HANDICAPPED PARKING SPACES"

WHEREAS, the Municipal Code of the City of Brigantine (the "City") provides in Chapter 284 for certain vehicle and traffic controls; and

WHEREAS, Section 284-32, Article III provides for Handicapped parking; and

WHEREAS, the City Council of the City of Brigantine wishes to provide for certain additional, restricted handicapped spaces within the City.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BRIGANTINE IN THE COUNTY OF ATLANTIC, STATE OF NEW JERSEY AS FOLLOWS:

Section 1. §284-32. Article III: Handicapped parking is amended and supplemented as follows:

- A. The locations described in Schedule XXIII (§ 284-59), included herein and made a part of this chapter, are hereby designated as handicapped parking spots.
- B. Any resident of the City of Brigantine possessing a valid New Jersey driver's license who has qualified for a handicapped parking permit from the State of New Jersey may apply to the City of Brigantine for a restricted handicapped parking space located near their residence. The application shall be submitted to the City Manager with a current copy of the applicant's handicapped parking permit and valid driver's license issued by the State of New Jersey.
- C. Consideration will be given to non-driving applicants for restricted curbside spaces providing that it is shown that there is a hardship in dropping off the handicapped applicant at their residence and subsequently parking the vehicle at another location. The nondisabled driver must reside in the same household as the disabled person and provide verification of such status.
- D. Restricted handicapped spaces will not be provided to applicants who have access to driveways and/or to other off street parking facilities.
- E. The number of handicapped restricted spaces on each City block will be limited: Two spaces will be allotted per street side per block with a maximum of four (4) available spaces. The intent is to provide a fair distribution of accessible spaces that are compliant with the above guidelines to both handicapped and non-handicapped residents of the City.

- F. Applicants shall have the option of requesting a designated space with a personal restriction that shall be defined by their New Jersey license plate number being printed on the signs delineating their space which shall be established by ordinance.
- G. There will be a one-time fee of \$75.00 for a restricted handicapped parking space. All handicapped parking spaces shall be subject to annual review. Applicants shall be required to provide a copy of current status of valid New Jersey handicapped status, driver's license and vehicle registration.
- H. Restricted handicapped spaces designated by ordinance shall be listed in §284-59, Schedule XXIII: Handicapped Parking Spaces Restricted by New Jersey Plate Number and Designated by Ordinance.
- I. A handicapped parking permit may be suspended or revoked by the City of Brigantine if the holder thereof has committed fraud or misrepresentation in any application for a permit or in the use of such handicapped parking permit or has violated any provision of this chapter. Additionally, any individual to whom a restricted spot has been granted who is found to be regularly utilizing on-street parking in the immediate vicinity of the location of the restricted space that has been provided to such individual, instead of utilizing such restricted space, shall be subject to suspension or revocation of such restricted parking space. No suspension or revocation shall occur prior to a hearing being held before an Administrative Board, to consist of three persons: the City Clerk, the City Manager, and the Chief of Police. Prior to such hearing, the affected person(s) and/or firm(s) shall receive notice of said hearing and shall have an opportunity to present a defense.

Section 2. All other provisions contained in §284-39 shall remain in full force and effect.

Section 3. Repealer, Severability, and Effective Date.

- A. Repealer. Any and all Ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies.
- B. Severability. In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable for any reason, then the City Council hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that it allows the City to meet the goals of the Ordinance.
- C. Effective Date. This Ordinance shall take effect upon proper passage in accordance with the law.

WHEREAS, the possession, housing, raising and maintenance of livestock in the City of Brigantine is inconsistent with the general good health and well-being of persons in the City of Brigantine; and

WHEREAS, it is the intention of City Council to insure the public health and well-being of all persons and cleanliness consistent with the presentation of the City of Brigantine to all residents and visitors; and

WHEREAS, in furtherance of such goals, it is the intention of City Council to prohibit the possession and housing of livestock in the City.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BRIGANTINE IN THE COUNTY OF ATLANTIC, STATE OF NEW JERSEY AS FOLLOWS:

<u>Section 1</u>. There is added to the Brigantine Municipal Code Section 153-11A in Article III, which will provide as follows:

The possession, housing, raising, and maintenance of any livestock in the City of Brigantine, including but not limited to horses, cows, bulls, pigs, and goats, is hereby prohibited.

- <u>Section 2</u>. Any and all Ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies.
- <u>Section 3</u>. Severability. In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable for any reason, then the City Council hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that it allows the City to meet the goals of the Ordinance.

<u>Section 4</u>. This Ordinance shall take effect after final adoption and publication in accordance with law.

SECTION III: Severability

If any section or part of this ordinance is deemed to be invalid or illegal in any court or competent jurisdiction then said part is severable from this ordinance as a whole and the remaining selections or parts of this ordinance shall remain in full force and effect.

All ordinances or portions thereof inconsistent with this ordinance are hereby repealed to the extent of said inconsistency.

WHEREAS, HOB37, LLC (the "Property Owner") is the owner of the real property currently known as Lot 8 in Block 1505 as shown on the current tax map of the City of Brigantine, said property is commonly known as 1504 W. Brigantine Avenue, (the "Subject Property") in the City of Brigantine, County of Atlantic and State of New Jersey; and

WHEREAS, the Property Owner purchased the Subject Property subject to a Walker Restriction; and

WHEREAS, the Property Owners have received approval from the Brigantine Planning Board to subdivide the subject property conditioned upon the City's waiver of enforcement of the Walker Restriction; and

WHEREAS, the Property Owners have requested the City of Brigantine waive any right or interest it may have to enforce said restrictions; and

WHEREAS, in consideration for agreeing to waive any right or interest it may have to enforce said restrictions the Property Owners have agreed to pay the City the sum of Twenty-five thousand dollars (\$25,000.00) and to release any and all claims of any nature against the City of Brigantine, all of which the City of Brigantine has relied upon in adopting this Resolution; and

WHEREAS, pursuant to State statute a municipality is authorized to waive, release, modify or subordinate any terms, covenants, conditions, limitations or reverters imposed in sales and conveyances of land made by said municipality after public hearing before the governing body once such proposed action has been advertised once each week for two weeks; and

WHEREAS, the required notice was pu	ublished in the Press of Atlantic City on
, 2020 and	, 2020, a copy of the proof of publication is
attached to this Resolution as Exhibit A; and	

WHEREAS, prior to the adoption of this Resolution, a public hearing was held before the City Council of the City of Brigantine; and

WHEREAS, the Property Owners and the City of Brigantine desire to enter into the agreement to waive any right or interest the City of Brigantine may have to enforce the Walker Restrictions on the Subject Property.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Brigantine that the City Manager and the City Clerk are authorized to execute an agreement with the Property Owners to waive any right or interest the City of Brigantine may have to enforce the Walker Restrictions on the real property currently known as Lot 8 in Block 1505 as shown on the current tax map of the City of Brigantine. A copy of the draft agreement is attached to this Resolution as Exhibit B.

BE IT FURTHER RESOLVED that the City Manager and the City Clerk are authorized to execute and send for recording any documents to effectuate the release of said rights.

AGREEMENT TO WAIVE THE RIGHT OF ENFORCEMENT ON THE WALKER RESTRICTIONS ON LOT 8 IN BLOCK 1505

(hereinafter the "Property Owner"), 150	4 W. Briganti	ne Avene, Brigantine, New Jersey 08203.

- **WHEREAS**, on December 10, 1945, the City entered into an agreement with Samuel D. Walker (hereinafter "Walker") for the transfer of various City owned real property; and
- WHEREAS, pursuant to said agreement, Walker would sell said property subject to a deed restriction (the "Walker Restrictions") which prohibited the subdivision of the same into lots with less than eighty (80) foot of frontage; and
- WHEREAS, HOB37, LLC (the "Property Owner") is the owner of the real property currently known as Lot 8 in Block 1505 as shown on the current tax map of the City of Brigantine, said property is commonly known as 1504 W. Brigantine Avenue, (the "Subject Property") in the City of Brigantine, County of Atlantic and State of New Jersey; and
- **WHEREAS**, the Property Owner purchased the Subject Property subject to a Walker Restriction; and
- **WHEREAS**, the Property Owner has received approval from the Brigantine Planning Board to subdivide the Subject Property, contingent upon the City's waiver of enforcement of the Walker Restriction; and
- **WHEREAS**, the Property Owner has requested the City of Brigantine waive any right or interest it may have to enforce said restriction; and
- WHEREAS, in consideration for agreeing to waive any right or interest it may have to enforce said restrictions the Property Owner has agreed to pay the City the sum of Twenty-Five thousand dollars (\$25,000.00) and to release any and all claims of any nature against the City of Brigantine, all of which the City of Brigantine has relied upon in adopting this Resolution; and
- **WHEREAS**, the Property Owner and the City of Brigantine desire to enter into the agreement to waive any right or interest the City of Brigantine may have to enforce the Walker Restrictions on the Subject Property.
- **NOW, THEREFORE**, with the parties intending to be bound by this agreement, having read and understood this agreement and acknowledging that adequate consideration has been exchanged regarding the same, they do hereby agree as follows:
- 1. <u>Recitals Incorporated</u>: The above recitals are incorporated into this section of the agreement as if more fully set forth at length herein.

- 2. Waiver of Enforcement of Restrictions: Pursuant to the terms and conditions as set forth in this agreement, and the memorializing Resolution, and with the understanding that there are particular and peculiar circumstances which affect this particular lot, and with the understanding that any waiver by the City Council is applicable solely to this lot, said lot being Lot 8 in Block 1505 as shown on the tax map of the City and further conditioned upon any and all consideration as set forth in this Agreement and subject to official municipal action as described herein, the City specifically waives any right or interest it may have to enforce the Walker Restrictions on Lot 8 in Block 1505. The City further agrees that once the subject property is subdivided in accordance with the Brigantine Planning Board approval, the City shall have no right to enforce the Walker Restrictions on the newly configured Lot8 in Block 1505.
- 3. <u>Consideration</u>: The full consideration to be paid to the City shall be the sum of Twenty-Five thousand dollars (\$25,000.00). Said sum shall be paid in a single certified or a Title Company check made payable to the City of Brigantine and shall be returned with a fully executed copy of this agreement. The check shall be payable to the City upon the signing of this Agreement and the recording of any document with the Clerk of Atlantic County to effectuate the waiver of any right or interest the City may have to enforce the Walker Restriction on the Subject Property.
- 4. <u>Fees and Costs</u>: The Property Owner shall be responsible for all fees and costs associated with the execution of this agreement and any fees associated with the recording of documents with the Atlantic County Clerk's Office.
- 5. Who is Bound: All of the parties are bound by this agreement and any person claiming an interest in the property on the date the same was purchased by the Property Owner until the signing of this agreement. Also bound by this agreement is anyone who succeeds to the rights and responsibilities of the parties including, but not limited to, any heir, executor, successor, affiliated corporation or successor corporation.
- 6. No Acknowledgement of Liability: This agreement is entered into after the parties have fully reviewed and understood the same and have had the opportunity to confer with competent counsel regarding the same. This document is simply entered into to effectuate the compromise between the parties, the release between the parties and the waiver of the deed restrictions and is not to be deemed as an indication of wrongdoing buy any of the parties herein.
- 7. No Waiver by the City of the Right to Enforce Restrictions in the Future: The specific understanding and agreement between the parties, which the City has materially relied upon in entering into this agreement and which is to be considered part of the consideration for this agreement, is that this agreement and the terms contained herein shall in no way be determined as a waiver and/or release by the City of its right to enforce the deed restrictions as set forth in the agreement between the City and Samuel D. Walker concerning any and all other lots and properties within the City and Samuel D. Walker. The parties understand and agree that it is specifically the intention of the City to enforce any and all such restrictions in a vigorous manner in the future and the City reserves all rights in that respect and the signing of this agreement shall in no way be deemed a waiver of said rights or a waiver or release of said deed restrictions concerning any other lot or property. This agreement is specifically intended to

affect, be relative to and touch upon only the lots in questions, said lot being Lot 8 in Block 1505 as shown on the current tax map of the City of Brigantine, said property is commonly known as 1504 W. Brigantine Avenue, Brigantine, County of Atlantic and State of New Jersey.

- 12. <u>Waiver</u>: Any waiver or notice by either party under this Agreement or any breach by the other party shall not affect similar rights subsequently arising, nor operate as a

waiver of subsequent breaches of the same or similar kinds, nor as a waiver of the clause or condition under which said right arose or said breach occurred.
