CITY OF BRIGANTINE ORDINANCE NO. 10 OF 2025

AN ORDINANCE TO SUPPLEMENT CHAPTER 210 OF THE CODE OF THE CITY OF BRIGANTINE, ENTITLED "MERCANTILE BUSINESSES" TO FURTHER DEFINE ICE CREAM TRUCK OPERATIONS AND FOOD TRUCK OPERATIONS

WHEREAS, the City seeks to supplement Chapter 210 of the City Code to further define where ice cream trucks may operate;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Brigantine in the County of Atlantic, State of New Jersey, that Chapter 210 is amended and supplemented as follows:

ARTICLE I. Amendment and Supplement to Chapter 210-30 entitled "Place where peddling permitted."

The existing paragraph is re-lettered paragraph "A" and the code is supplemented to add a new paragraph "B" and "C" to read as follows:

"B. Ice Cream Truck Operations - Beach Street Ends

Ice cream trucks are permitted to operate only at public beach street ends between 14th Street South and 14th Street North. At no time may music, horns, or any other loud sounds be broadcast from the vehicles.

Operators are allowed to walk onto the approved public beach area up to the dune line closest to the water. To alert beachgoers of their presence, they may ring a handheld bell at the beach entrance—no other forms of noise are permitted."

"C. Food Truck Operations

Food trucks may be permitted for special events upon approval of a Special Event Permit obtained through the Administration Office."

ARTICLE II. Repealer, Severability, and Effective Date.

- A. Repealer. Any and all Ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies.
- B. Severability. In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable for any reason, then the City Council hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that it allows the City to meet the goals of the Ordinance.

C. Effective Date. This Ordinance shall take effect upon proper passage in accordance with the law.

CITY OF BRIGANTINE ORDINANCE NO. 11 OF 2025

AN ORDINANCE TO AMEND THE CITY CODE IN VARIOUS PLACES CONCERNING TAXICABS

WHEREAS, the City Manager, in consultation with various municipal officials, determined that the City no longer seeks to license taxi-cabs or identify specific fixed locations for taxi-stands;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Brigantine in the County of Atlantic, State of New Jersey, that the City Code is amended and supplemented as follows:

ARTICLE I. Repeal of Chapter 270.

This City Council determines to repeal Chapter 270 in its entirety.

ARTICLE II. Amendments to Chapter 284

Chapter 284-30 is repealed and replaced with the following language:

"§284-30. Parking of taxicabs on streets within City prohibited.

No taxicab of any nature shall be parked on or in any street, boulevard, avenue, road, highway, cul-de-sac, alley or other area of public travel within the City of Brigantine except for the purpose of picking up or dropping off passengers. This section is specifically intended to prevent the parking of taxicabs in the City of Brigantine in any district, whether it be residential or commercial, except for the stated purpose of picking up or dropping off passengers."

Chapter 284-57 is repealed for consistency with this ordinance.

ARTICLE III. Repealer, Severability, and Effective Date.

- A. Repealer. Any and all Ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies.
- B. Severability. In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable for any reason, then the City Council hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that it allows the City to meet the goals of the Ordinance.
- C. Effective Date. This Ordinance shall take effect upon proper passage in accordance with the law.

CITY OF BRIGANTINE ORDINANCE NO. 12 OF 2025

AN ORDINANCE TO AMEND VARIOUS SECTIONS OF THE MUNICIPAL CODE TO UPDATE THE RANK STRUCTURE OF THE FIRE DEPARTMENT TO FURTHER REMOVE THE TERM "DIRECTOR OF PUBLIC SAFETY"

- WHEREAS, Chapter 3 "Administration," Article X "Public Safety and Enforcement Departments" of the Code of the City of Brigantine (the "Code") governs the Departments of Police, Fire, and Emergency Medical Services, the Beach Patrol, the Ordinance Enforcement Department and the Uniform Construction Code Enforcement Office of the City of Brigantine; and
- WHEREAS, at the recommendation of the Fire Chief, the City wishes to update the rank structure of the Fire Department for consistency with federal standards and uniformity with adjacent departments; and
- WHEREAS, by referendum in 2014, the position of "Director of Public Safety" is not authorized in the City but remnants of that term and position remain in the municipal code; and
- WHEREAS, the Brigantine City Council is desirous of amending the Code to eliminate references to the "Director of Public Safety" position to consistency with the 2014 referendum; and
- WHEREAS, the changes are budget neutral;
- NOW, THEREFORE, BE IT ORDAINED AND ENACTED, by the Brigantine City Council, County of Atlantic, State of New Jersey, that various sections of the municipal code are amended as follows:
- ARTICLE I: Article X of Chapter 3 of the City Code entitled "Public Safety and Enforcement Departments" is amended to read as follows:
- § 3-43 repealed in its entirety and reserved for future use.
- § 3-44 Department of Police, at paragraph (c) is amended to strike the words "the Director of Public Safety".
- § 3-45 Department of Fire and Emergency Medical Services is amended at Paragraph (A) to strike the words "The Director of Public Safety, under the direction of the City Manager," and replaced with "The City Manager".
- §3-45 is further amended to repeal and replace Paragraph (B) in its entirety to read as follows:

- B. The Fire Department shall consist of the Chief and such subordinate and intermediate supervisory officers as are authorized by the City Council, which are:
 - 1) Fire Chief
 - 2) Deputy Chief
 - 3) Battalion Chief
 - 4) Captain
 - 5) Firefighter/EMT
 - 6) Fire Official/EMT
- § 3-45 is further amended to repeal Paragraph (C) in its entirety.
- § 3-45 Department of Fire and Emergency Medical Services is amended at Paragraph (D) to strike the words "the Director of Public Safety".
- §3-46 Beach Patrol is amended at Paragraph A to remove the phrase "Director of Public Safety, under the direction of the".
- §3-46 Beach Patrol is amended at Paragraph B to remove the rank "Senior Lieutenant" and renumber paragraphs 4 through 6.
- §3-46 Beach Patrol is amended at Paragraph C to remove the phrase "the Director of Public Safety".
- §3-47 Ordinance administration and enforcement is amended at Paragraph A(1), B(1), C(1), D(1), E(1) and F(1) to remove the "Director of Public Safety, under the direction of the" from each paragraph.
- §3-48 Uniform Construction Code Office is amended at Paragraph A to remove the phrase "Director of Public Safety, under the Direction of the" and the phrase "Public safety Director and the" from Paragraph B.
- §3-48 Emergency Management Services Office is amended at Paragraph A to remove the phrase "Director of Public Safety, under the Direction of the".
- §3-74 Benefits and conditions of employment is amended at Paragraph A to remove the phrase "Director of Public Safety" from the list of full-time employees consistent with this ordinance.

ARTICLE II: Chapter 230 of the City Code entitled "Parades and Assemblies" is amended as follows:

References to the "Director of Public Safety" in Chapter 230-1, -2, -3, -4 and -5 are amended to remove that term and replace with "City Manager".

ARTICLE III: Chapter 234 of the City Code entitled "Parking Lots" is amended as follows:

References to the "Director of Public Safety" in Chapter 234-3, -4 and -5 is amended to remove that term and replace with "City Manager".

ARTICLE IV: Chapter 250 of the City Code entitled "Second Hand Dealers" is amended as follows:

References to the "Director of the Department of Police" in Chapter 250-6(A)(4) and 250-10(A) are amended to remove that term and replace with "Police Chief".

ARTICLE V: Chapter 278 of the City Code entitled "Towing" is amended as follows:

Chapter 278-33(A) is amended to remove the phrase "and the Director of Public Safety" for consistency with this ordinance.

ARTICLE VI: Chapter 284 of the City Code entitled "Vehicles and Traffic" is amended as follows:

Section 284-3 of the City Code entitled "Authorization for closing of any street" is amended to repeal and replace Paragraph A to read as follows:

"A. The City Manager or in the event of the Manager's absence, disability or inability to act, then the Chief of Police of the municipality is hereby authorized to provide by regulation for the closing of any street or portion thereof to motor vehicle traffic during specified hours on any day or days whenever the City Manager finds that such closing is necessary for the preservation of the public safety, health or welfare."

Section 284-35 of the City Code entitled "Posting of signs." is amended to repeal and replace Paragraph A to read as follows:

"A. Upon the declaration of an emergency, there shall be no parking upon streets or parts of streets where temporary emergency no parking signs are displayed. The Emergency Management Coordinator, or the Coordinator's designee, is authorized to declare an emergency and to direct the posting of said emergency no parking signs when weather conditions, accidents, fires or public celebrations dictate or require the avoidance of hazards or other conditions which interfere with the free flow of traffic,

or to take appropriate steps to eliminate parking or travel over public streets or portions thereof."

ARTICLE VII: General Provision.

Any further reference to the Position of the "Director of Public Safety" not specifically mentioned herein is amended to state "City Manager, or the Manager's designee."

REPEALER, SEVERABILITY AND EFFECTIVE DATE.

- A. <u>Repealer</u>. Any and all ordinances inconsistent with the terms of this ordinance are hereby repealed to the extent of any such inconsistencies.
- B. <u>Severability</u>. In the event that any clause, section, paragraph or sentence of this ordinance is deemed to be invalid or unenforceable for any reason, then the City Council hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that it allows the City to meet the goals of the ordinance.
- C. This ordinance shall take effect upon passage and publication according to law.

AN ORDINANCE TO AMEND CHAPTER 260 OF THE CODE OF THE CITY OF BRIGANTINE, ENTITLED "STREETS AND SIDEWALKS" TO REMOVE ESCROW FEES FROM THE REVOCABLE LICENSE APPLICATION PROCESS

WHEREAS, the City amended Chapter 260 of the City Code last year and after a year of implementation seeks to further amend this section of the Code to remove the requirement for establishing escrow for revocable license applications;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Brigantine in the County of Atlantic, State of New Jersey, that Chapter 260 is amended and supplemented as follows in the below specific locations with no further changes to other sections of the Code.

ARTICLE I. Amendments to Chapter 260.

§ 260-9(E) is repealed and replaced to read as follows:

E. The property owner shall pay to the City a one-time application fee in cash or check issued to the City of Brigantine submitted with the application. The application fees are established in Chapter 210-37 of the Code as may be amended from time to time.

§ 260-10(I) is repealed and replaced to read as follows:

A nonrefundable application fee as set forth more fully in § 260-9 of this chapter.

ARTICLE II. Repealer, Severability, and Effective Date.

- A. Repealer. Any and all Ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies.
- B. Severability. CITY OF BRIGANTINE ORDINANCE NO. 14 OF 2025

AN ORDINANCE AMENDING ORDINANCE 2024-10 WHICH VACATED THE 20' PAPER STREET ALONG ATLANTIC BRIGANTINE BOULEVARD BETWEEN BOOT ISLAND AND BLOCK 3401, LOTS 1-14 TO PROVIDE ADDITIONAL CLARITY AS TO OWNERSHIP OF THE VACATED LANDS

WHEREAS, the City of Brigantine adopted Ordinance 2024-10 vacating the 20 foot paper street along Atlantic Brigantine Boulevard between Boot Island and Block 3401, Lot 1-14; and

WHEREAS, typically such lands are equally divided with half going to each side of the right of way, however, in this case, the City is the owner of Boot Island to the North and all 20 feet shall be vacated in favor of the individual property owners to the Southside of the paper street; and

NOW, THEREFORE, BE IT ORDAINED AND ENACTED, by the City Council of the City of Brigantine, County of Atlantic and State of New Jersey as follows:

- 1. The City Council of the City of Brigantine confirms that the vacated the 20' paper street, located between Boot Island (to the North) and Block 3401, Lots 1-14 (to the South), designed to run between Cherokee Boulevard (to the West) and Edgewater Drive (to the East) shall provide all 20' feet to the lands to the owners of Lots 1-14 with no lands transferring to Boot Island to the North.

CITY OF BRIGANTINE ORDINANCE NO. 15 OF 2025

AN ORDINANCE TO MAKE CERTAIN FINES AND PENALTIES PAYABLE OFFENSES

WHEREAS, the City Manager, in consultation with various municipal officials, determined that several sections of the Code require amendment to address payable fines;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Brigantine in the County of Atlantic, State of New Jersey, that the City Code is amended and supplemented as follows:

ARTICLE I. Amendment to Chapter 105-6(G)

This City Council that Chapter 105-6(G) shall read as follows:

"Violations for driving on the beaches in the City of Brigantine without a valid 4x4 Permit shall be punishable through a payable fine of \$350. If the offending party wishes to appear in Municipal Court and plead not guilty to the citation, the matter will be heard before the Court and upon conviction, the offending party shall be subject to a fine of not more than \$2,000, by imprisonment for a term not to exceed 90 days or by community service of not more than 90 days, or any combination of fine, imprisonment or community service as determined in the discretion of the Municipal Court Judge. Any person found guilty of a second and/or subsequent offense may be prohibited from accessing municipal beaches or recreational areas for a one-year period commencing on the date of conviction. Any vehicle found in violation of any section of this article is subject to be removed from the beach area on order of any officer charged with enforcement of this article. Any vehicle which presents a hazard to safety, navigation or property may also be removed. All costs for such removal shall be the responsibility of the operator, permittee, or registered owner of the vehicle."

ARTICLE II. Amendment to Chapter 91-5

This City Council that Chapter 91-5 shall read as follows:

"Violations for consumption in public in the City of Brigantine shall be punishable with a fine of \$150. If the offending party wishes to appear in Municipal Court and plead not guilty to the citation, the matter will be heard before the Court and upon conviction, the offending party shall be subject to a fine of not more than \$2,000, by imprisonment for a term not to exceed 90 days or by community service of not more than 90 days, or any combination of fine, imprisonment or community service as determined in the discretion of the Municipal Court Judge. Any person found guilty of a second and/or subsequent offense may be prohibited from accessing municipal beaches or recreational areas for a one-year period commencing on the date of conviction."

ARTICLE III. Repealer, Severability, and Effective Date.

- A. Repealer. Any and all Ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies.
- B. Severability. In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable for any reason, then the City Council hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that it allows the City to meet the goals of the Ordinance.
- C. Effective Date. This Ordinance shall take effect upon proper passage in accordance with the law.
