SECTION 3: All salaries and waged as listed in Section 2 shall be paid bi-weekly and shall become effective once adopted. Persons currently holding positions shall be paid within the specified ranges as listed in Section 2, t be determined by the City Manager who will consider experience, education and other relevant factors.

SECTION 4: Seasonal positions shall become effective with the beginning of the summer season. The Beach Patrol Officers must work a minimum of 70 days. Failure to do so will result in a pro-rata reduction of salary based upon the Officer's daily rate of pay.

\$.50 for each additional year thereafter up to the maximum hourly rate established in this ordinance. Part Time Dispatchers shall be entitled to be paid at the rate of one and one-half times their regular hourly rate (1 ½) for all hours worked on a Premium Holiday as defined in the current GWU Local 300 Collective Bargaining Agreement. Part Time Dispatchers who maintain a current NJ or National Registry EMT Certification shall be entitled to an annual stipend of seven hundred Fifty dollars (\$750.00).

SECTION 6: Longevity was eliminated for all employees. Employees that have received longevity in the past will maintain the longevity amount that has already been added to their base but will no longer be eligible to receive longevity from January 1, 2014.

SECTION 7: A copy of this Salary Ordinance shall remain on file in the office of the Municipal Clerk and be available for inspection during office hours.

SECTION 8: All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 9: This ordinance shall take effect after final adoption and publication as prescribed by law.

NOW, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BRIGANTINE IN THE COUNTY OF ATLANTIC AND STATE OF NEW JERSEY AS FOLLOWS:

SECTION I: Section 284-59 of the Code of the City of Brigantine shall be amended be adding the following space as a designated handicap space within the City of Brigantine:

NAME OF STREET 344 31st Street South

LOCATION

Twenty (20) foot area on the front side of the property located at 344 31st Street South

SECTION II: Upon adoption by the City Council of the City of Brigantine of this Ordinance, the Department of Public Works and all other appropriate entities area authorized to take any and all steps to erect the appropriate signs designating the above space as a handicap parking space and to take any other action to fulfill the intention of this Ordinance.

SECTION III: Severability

If any section or part of this Ordinance is deemed to be invalid or illegal in any court or competent jurisdiction then said part is severable from this Ordinance as a whole and the remaining selections or parts of this Ordinance shall remain in full force and effect.

ENDORSING ATLANTIC COUNTY WATER QUALITY MANAGEMENT PLAN AMENDMENT

WHEREAS, the City of Brigantine desires to provide for the orderly development, continuation and management of wastewater facilities within the City of Brigantine; and

WHEREAS, by decision made on May 24, 2023, which was memorialized by Resolution No. 1-2023 dated June 28, 2023 the City of Brigantine Planning Board granted amended preliminary and major subdivision approval to Rockwell Brigantine, LLC, the owner of a 45-acre property identified on the City of Brigantine Tax Map as Lot 1, Block 1, located on Atlantic Brigantine Boulevard (County Route 638), granting Rockwell Brigantine, LLC approval to subdivide the above property into eighteen (18) lots of record, fourteen (14) of which will be developed with conforming single-family residences, one (1) reserved for open space and landscaping, two for stormwater improvements, and one (1) reserved to remain in a wetlands area; and

WHEREAS, through its Engineer, Rockwell Brigantine, LLC has prepared a proposed amendment to the Atlantic County Water Quality Management Plan ("WQMP"), as shown on the attached Sewer Service Area Amendment Plan, which amendment would expand the Atlantic County sewer service area (SSA) by 0.991 acres to allow for the construction of 14 single-family residences with associated stormwater improvements on the property;

WHEREAS, the New Jersey Department of Environmental Protection ("NJDEP") requires that proposed wastewater treatment and conveyance facilities and wastewater treatment service areas, as well as related subjects, conform with an approved Water Quality Management Plan ("WQMP"); and

WHEREAS, Atlantic County has established the "Atlantic County Water Quality Management Plan Procedures" (the "procedures") which contains the procedures for review, approval, and adoption of proposals to amend the Atlantic County WQMP; and

WHEREAS, Atlantic County Code Section 129-9F.(1) requires that the City concurs or does not object to the proposed SSA amendment; and

WHEREAS, by this resolution, the City of Brigantine hereby endorses the proposed amendment to the Atlantic County WQMP; and

WHEREAS, the New Jersey Department of Environmental Protection has established the WQMP amendment procedure through the WQMP rules at N.J.A.C. 7:15-3.5 as the method of incorporating unplanned facilities into a WQMP".

NOW, THEREFORE, BE IT RESOLVED, by the Members of the City of Brigantine, in the County of Atlantic and State of New Jersey, as follows:

- 1) All of the statements of the preamble are repeated and are incorporated herein and made a part hereof by this reference thereto.
- 2) The City of Brigantine hereby endorses the proposed amendment to the Atlantic County WQMP as shown on the as depicted on the attached Sewer Service Area Amendment Plan.
- 3) This consent shall be submitted to the Atlantic County Department of Regional Planning and Development in accordance with Atlantic County Code Section 129-9F.(1) and to the New Jersey Department of Environmental Protection in accordance with the provisions of N.J.A.C. 7:15-3.5.
