WHEREAS, the City of Brigantine has, pursuant to various ordinances, a set fee schedule for permits issued within the municipality; and

WHEREAS, Comfort Now, located at 1188 Ocean Heights Avenue, Egg Harbor Township, New Jersey 08234, applied for HVAC Permit No. 2025-372 for Block 2603, Lot 4, located at 101 27th Street South, Brigantine, New Jersey 08203; and

WHEREAS, Comfort Now subsequently withdrew the permit after the homeowner opted to place the work on hold indefinitely; and

WHEREAS, the total permit fee was \$420.00, and pursuant to Sections 5:23-2.26 and 5:23-2.27 of the Uniform Construction Code adopted by the State of New Jersey, a 20% review fee of \$84.00 is retained, resulting in a refundable amount of \$336.00; and

NOW, THEREFORE, BE IT RESOLVED by the Municipal Council of the City of Brigantine, County of Atlantic, State of New Jersey, that the Chief Financial Officer is hereby authorized to issue a refund in the amount of \$336.00 to Comfort Now.

COUNCIL MANAGER / COMMITTEE DISCUSSION

- **Tige Platt** reported that the Food Truck Festival was a hugely successful event. Strong sales, and feedback from attendees was positive. Going forward, the event will remain at Hanneman Park.
- **Mayor Vince Sera** shared that he received great feedback regarding parking for the Food Truck Festival and praised the utilization of Hanneman Park for the event.
- **Paul Fuller** reminded the Council and public of the upcoming 9/11 Remembrance Ceremony, scheduled for Thursday at 9:30 AM.
- **Deputy Mayor Bew** thanked all City employees for keeping the community safe and acknowledged the business community, including the Chamber of Commerce. She noted record breaking activity at the golf course and shared that there is one Farmers Market remaining. She described the past weekend as phenomenal and wished everyone a happy early fall.
- Councilman Lettieri reported that conditions have calmed down at the north end. He clarified that the recent designs were not initiated by the City. He confirmed the promenade is safe for walking and thanked the Fire Department, Police Department, and John Doring, Superintendent of Public Works.

- Councilman Haney echoed the sentiments of Deputy Mayor Bew and Councilman Lettieri, thanking the Police Department, Fire Department, Public Works, and Beach Patrol. He also thanked Deputy Mayor Bew for the prayer. He praised the recent weather and encouraged residents to enjoy the remainder of the summer and the upcoming fall season in Brigantine.
- Councilman Kane reflected on an amazing and extremely busy summer. He reported that businesses did very well and commended **John Doring**, Superintendent of Public Works, for his efforts.
- Councilman Riordan by voice resolution nominated Barbara Caniglia as a member of the Cultural Arts Committee Motion: Councilman Lettieri Seconded: Councilman Haney Roll Call: All present voted Aye; The motion passed. He thanked Public Works, Police, Fire, and Beach Patrol for their continued service. He highlighted several upcoming events, including *Jaws on the Beach*, the 9th Annual Cornhole Tournament, a Bonfire on the Beach, and the first Eagles tailgate.
- Mayor Sera noted Brigantine's city employees for their dedication and teamwork in managing growing challenges each year. He shared updates from a recent meeting with Congressman Van Drew and the Army Corps of Engineers, and NJDEP following Hurricane Erin. Topics included beach erosion and flood mitigation. Mayor Sera encouraged homeowners to support congressional efforts and stressed the importance of direct communication with decision makers.

- Wayne Achey, of 403 Bayshore Avenue, expressed concerns about safety near the boat ramp. He noted that boats are frequently coming in and out. He and his wife Karen are concerned for public safety. Traffic cones had been set up but were later removed. Wayne also inquired about the contract and previous meeting minutes regarding Colliers and the area near 5th and 6th Streets.
- Councilman Kane added that there are pedestrians frequently walking to the Elks Lodge in that vicinity.
- Tiger Platt reported that a grant has been secured for improvements. Engineers will begin design work, including the installation of large electronic signs to alert drivers.
- Trisha Cosgrove announced that the 2026 Polar Bear Plunge will take place on a Thursday, with visitors typically staying through the following Monday. She also noted that this year marks the 100th anniversary of both the Polar Bear Plunge and the construction of the Fischer House.
- Mayor Sera approved moving forward with the planning process.
- John Johnson of 36 Coquille Beach Dr, thanked the Fire Department, Police Department, Beach Patrol, and Public Works for doing an exceptional job. He also commented that the Pepper Cove area looks great.

Mayor Sera closed the public portion.
