WHEREAS, it has been determined by the Tax Collector that the taxpayers as indicated on the attached Schedule “A” are entitled to overpayment refunds and;


WHEREAS, it is the desire of the Council of the City of Brigantine to have these overpayments returned to the respective taxpayers;

WHEREAS, Northeast Electrical & GC Services has submitted a proposal to complete the installation; and





WHEREAS, Comfort Now subsequently withdrew the permit after the homeowner opted to place the work on hold indefinitely; and



WHEREAS, the City of Brigantine received five proposals for the project with Polistina & Associates as the lowest responsible bidder and;


