WHEREAS, Brigantine Boulevard (CR638) and Bayshore Avenue intersect at the area commonly referred to as "Lighthouse Circle Intersection" in the City of Brigantine; and

WHEREAS, the City and the County jointly recognize that it is in the best interests of the surrounding community and the travelling public to improve the Lighthouse Circle intersection; and

WHEREAS, the City and the County jointly commissioned an independent traffic engineer to conduct a design study to determine preferred alternatives for improving this intersection; and

WHEREAS, the City and County received the Brigantine Lighthouse Intersection Study dated May 2019, reviewed the five identified conceptual design alternatives and selected Concept 2B-Offset Oval with Parking as the preferred alternative; and

WHEREAS, the City and County wish to proceed to the Preliminary and Final Design

Phase in furtherance of improving the Lighthouse Circle intersection; and

WHEREAS, the City and County wish to enter into an Agreement, in the form substantially as attached hereto, for a 50/50 cost share for all costs associated with the preparation of Preliminary and Final Design Construction Plans and documents, with a total estimated cost not to exceed \$200,000.00, with each party contributing fifty percent (50%) of the cost in an amount not to exceed \$100,000.00.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Brigantine that the Mayor, City Manager are authorized to enter into and execute the attached Agreement with the County of Atlantic for Preliminary and Final Design Construction Plans and documents to design improvements to the Lighthouse Circle Intersection at Brigantine Boulevard (CR638) and Bayshore Avenue for a total project cost not to exceed \$200,000.00, which cost shall be shared between the City and the County, with each party contributing fifty (50) percent of the cost to prepare the plans in an amount not to exceed \$100,000.00
