ORDINANCE 3 OF 2024**

**AN ORDINANCE TO AMEND CHAPTER 234 OF THE CODE OF THE CITY OF  
BRIGANTINE, ENTITLED "PARKING LOTS" TO UPDATE THE PARKING  
REGULATIONS IN CITY PARKING LOTS FOR PERMIT PARKING**

**WHEREAS**, Chapter 234 of the Code of the City of Brigantine (the "City"), entitled "Parking Lots," governs the parking of vehicles on public and private property; and

**WHEREAS**, Article I of Chapter 234 governs the parking of vehicles in various municipal parking lots throughout the City; and

**WHEREAS**, N.J.S.A. 40:48-2.46 permits the governing body of every municipality to make and amend ordinances to regulate vehicular traffic and the parking of vehicles in parking places open to the public, including public streets; and

**WHEREAS**, the City Council of the City of Brigantine believes it is in the best interests of the City residents to make amendments to Chapter 234 to effectively provide for the electronic payment of parking privileges for daily and seasonal parking and for the enforcement of parking regulations in lieu of the placement of identification tags on vehicles in all of the public parking lots.

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Brigantine in the County of Atlantic, State of New Jersey, that Chapter 234 of the Code of the City of Brigantine shall be amended and supplemented as follows (underlined text illustrates additions, strikethrough text illustrates deletions):

**ARTICLE I. AMENDMENTS TO EXISTING SECTIONS OF CHAPTER 234, ARTICLE I, ENTITLED "MUNICIPAL PARKING LOTS."**

§ 234-1 Registration and ~~identification tag required.~~ parking permit required.

- A. No person shall park any vehicle in any of the ocean front parking areas owned and maintained by the City of Brigantine for the time period beginning with the Friday of Memorial Day weekend and ending with the Monday of Labor Day weekend unless ~~such vehicle is registered with and bears an identification tag issued by the City of Brigantine as hereinafter provided.~~ such person obtains an electronic Daily or Seasonal Parking Permit for such vehicle. During the time period from Memorial Day weekend to Labor Day weekend when permit parking is required, no permit shall be necessary to park in ocean front municipal lots between the hours of 6:00 p.m. and 8:00 a.m.
- B. A Daily or Seasonal Parking Permit for parking in the municipal lots during the time period when permit parking is required can be secured upon arrival at a municipal lot using the pay-to-park Park Mobile™ payment system. Once paid for, parking for the

registered vehicle shall only be valid in the parking/lot zone associated with the mobile-pay purchase and the license plate associated with that registered vehicle shall serve as the proof of payment for that vehicle for parking enforcement purposes.

C. Payment for daily parking shall be made daily through use of the City's pay-to-park Park Mobile™ payment system utilizing a mobile cellular device. Daily parking spaces cannot be reserved or paid for in advance. Payment for seasonal parking shall be made prior to the commencement of the Friday of Memorial Day weekend through use of same payment system utilizing a mobile cellular device.

## ARTICLE II. Repealer, Severability, and Effective Date.

- A. Repealer. Any and all Ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies.
- B. Severability. In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable for any reason, then the City Council hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that it allows the City to meet the goals of the Ordinance.
- C. Effective Date. This Ordinance shall take effect upon proper passage in accordance with the law.

ORDINANCE 4 of 2024**

**AN ORDINANCE TO AMEND CHAPTER 105 OF THE CODE OF THE CITY OF  
BRIGANTINE, ENTITLED "BEACHES AND RECREATION AREAS" TO  
UPDATE REGULATIONS ICE CREAM PERMITS**

**WHEREAS**, Chapter 105 of the Code of the City of Brigantine (the "City"), entitled "Beaches and Recreational Area," governs, among other things, the licensing of ice cream vendors; and

**WHEREAS**, the City Manager, in consultation with City staff, has reviewed this process and recommends changes; and

**WHEREAS**, the City Council of the City of Brigantine believes it is in the best interests of the City residents accept and implement the recommended changes;

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Brigantine in the County of Atlantic, State of New Jersey, that Chapter 105, Section 105-4, Paragraph E of the Code of the City of Brigantine is repealed and replaced as detailed in this ordinance.

**ARTICLE I. REPEAL AND REPLACE SECTION 105-4(E) OF THE MUNICIPAL  
CODE**

The City Code at Section 105-4(E) entitled "Municipal beaches and recreational area permits" is repealed and replaced to read as follows:

**105-4(E) Municipal beaches and recreational area permits**

...

"E. Sale of Ice Cream on the Beaches.

(1) Notwithstanding any other Code section to the contrary, there shall hereby be authorized the sale of ice cream, packaged ice cream, water ice, popsicles, fudgesicles, ice cream cones, Dixie cups, ice cream sandwiches, frozen yogurt, water, and similar frozen ice cream products on the beach in the City of Brigantine pursuant to the terms and conditions as contained herein. All of the above products hereinafter shall be referred to as "ice cream."

(2) The City of Brigantine shall provide for ten (10) mercantile licenses to sell ice cream on the beach. Any veteran who held a license in the previous year shall have a first right of refusal to a current year license, provided that they submit their application by March 30<sup>th</sup> of the calendar year. All remaining mercantile licenses shall be offered on a first come, first serve basis, starting April 1<sup>st</sup> of the calendar year for the Summer season. Only valid mercantile license holders shall be authorized to sell ice cream on

the beaches in the City of Brigantine.

- (3) Only United States veterans who have been issued and hold a current and valid certificate pursuant to N.J.S.A. 45:24-9 may apply for a mercantile license to sell ice cream on the beach. The veteran must present the proper state or county vending identification to qualify. The mercantile licensee is the only person authorized to sell ice cream on the beach. The mercantile license to sell ice cream on the beach is not assignable or transferrable.
  - (a) In the event that there are an insufficient number of veterans applying for a permit, the City of Brigantine shall have the right to outsource to a vendor.
- (4) The mercantile licensee shall be prohibited from having any flag, banner, advertising, pinwheel, or other similar device or display on any box, container or equipment used to carry or transport the ice cream product to be sold. Notwithstanding this section, the display of a small American flag is permissible.
- (5) The carrying and transporting of ice cream products pursuant to this chapter is only permissible by:
  - (a) An insulated metal box with shoulder straps that is uniform in color; or
  - (b) A push cart that is uniform in color, has four wheels, is made of PVC pipe and has at least one trash receptacle attached thereto which is capable of holding a sufficient amount of trash and debris so that no litter results from the sale of ice cream on the beach.
- (6) Sale of ice cream on the beach shall only be permitted between the hours of 10:30 a.m. and 5:30 p.m. Sales shall be permitted from one week prior to Memorial Day until one week after Labor Day. Sale on the beach is also permitted for a special event on the beach outside of that time period if approval is received in advance from the City of Brigantine.
- (7) The sale of ice cream on the beach shall be authorized in a single zone. The established zone shall be on the beach starting at the northern promenade and proceeding in a southerly direction to the jetty and then in a westerly direction to the cove. It is the intention of this section to create a single zone extending from the northern promenade to the jetty and then to the Cove Recreational Area. Every mercantile licensee may traverse any section of the zone to sell ice cream.
- (8) Mercantile licenses to sell ice cream on the beach shall be subject to the following terms and conditions:
  - (a) Any person selling ice cream shall be at least 18 years of age or older.
  - (b) The photo mercantile license issued by the City of Brigantine must be visible at all times while selling ice cream on the beach.
  - (c) The applicant shall submit their fingerprints to the City of Brigantine Police



Department. The State of New Jersey has contracted with a vendor, Sagem Morpho, Inc., which performs this service. If the State changes such system, the City will utilize the existing State system without amendment to this chapter. The charge for the same shall be the sole responsibility of the applicant.

- (d) By submitting said fingerprints, any person authorizes the City of Brigantine and its police department and Sagem Morpho, Inc., to run a criminal background history and otherwise investigate each and every applicant to ensure they have not been convicted of a crime. No individual shall be authorized or permitted to sell ice cream on the beach in the City of Brigantine who has a criminal record.
- (9) The mercantile licensee shall be in violation of this chapter if any of the following occurs:
  - (a) Any person selling ice cream on the beach acts in an unprofessional, discourteous, intimidating, or offensive manner to a member of the general public.
  - (b) Any person selling ice cream on the beach pursuant to this chapter disregards or fails to obey any order or direction given to them by a member of the Brigantine Police Department or the Brigantine Beach Patrol.
  - (c) Any person selling ice cream on the beach pursuant to this chapter commits, conducts, or demonstrates a state of moral turpitude.
  - (d) Any person selling ice cream on the beach pursuant to this chapter makes a false or misleading statement or otherwise gives incomplete or incorrect information during the application process.
  - (e) Any person selling ice cream on the beach pursuant to this chapter violates any of the conditions or requirements of this chapter.
  - (f) Any person selling ice cream on the beach pursuant to this chapter sells any product which is not authorized or sells authorized products.
  - (g) Any person selling ice cream on the beach pursuant to this chapter improperly disposes of debris, boxes, or otherwise causes trash or litter to be disbursed or accumulate on the beaches of the City of Brigantine.
- (10) All individuals selling ice cream along the beach in the City of Brigantine are required to appear in a neat and clean manner. Must wear a shirt with sleeves and always represent a professional image.
- (11) No individual selling ice cream on the beach in the City of Brigantine may use any bell, whistle, horn, loud speaker, cymbal, siren, or other such means of drawing attention or promoting sales to said individual. Hawking in a reasonable

tone is permissible.

- (12) All individuals selling ice cream on the beach must comply with all federal, state, and local laws, rules, regulations, and ordinances, including any requirements of the Atlantic County Department of Health or other health department with jurisdiction, and are subject, without notice, to inspection of its product and equipment at any time by any state, county, or municipal official.
- (13) All equipment used by any individual to sell ice cream on the beach in the City of Brigantine shall be maintained in a clean, neat, and sanitary manner.
- (14) Every person selling ice cream on the beach pursuant to this chapter must wear the photo identification badge issued by the City of Brigantine. Additionally, there must be a prominent display of a price list setting forth the price of the items being sold by any individual selling ice cream on the beach pursuant to this chapter.
- (15) No restocking of ice cream product may occur on the beach in the City of Brigantine. To restock any product, the individual must leave the beach. No restocking may occur which would require a truck or other vehicle to be parked illegally in any street or parking lot located within the City of Brigantine. Any building, freezer, or other structure used to store ice cream products which are to be sold pursuant to this chapter, if located within the boundaries of the City of Brigantine, must be in conformity with the requirements of the Municipal Land Use ordinance of the City of Brigantine and with all national building codes and subcodes adopted and in use within the City of Brigantine.
- (16) All individuals selling ice cream on the beach shall sign an Indemnification and hold harmless agreement with the City of Brigantine indemnifying and holding harmless the City of Brigantine and any officials, employees or agents acting on its behalf from and against any and all losses, suits, cost, damages, claims, expenses, actions, liabilities or judgements whatsoever, including damage, personal injury or other damage or loss sustained or alleged to have been sustained in conjunction with the selling of ice cream on the beach, such indemnification and hold harmless agreement shall include, but not be limited to, indemnification for any and all claims by any party for royalties, patent infringements, food poisoning, or any other injury, loss or damage which are in any way related to the sale of ice cream on the beach by the Mercantile licensee.
- (17) Any person violating any provision of this Ordinance shall, upon conviction of the same, be punished for each offense by a fine not to exceed \$1,250.00, by imprisonment for a term not exceeding 90 days in the County jail or by being ordered to perform community service not in excess of 90 days, or any combination thereof as determined by the Municipal Court Judge. In addition, if any person is convicted of violating this Ordinance, the City of Brigantine reserves the right to terminate the license issued and/or reserves the right to exclude said person from applying in any subsequent year."

**ARTICLE II.** The remainder of Chapter 105-4 remains unchanged and unedited and in full force and effect.

**ARTICLE III.** Repealer, Severability, and Effective Date.

- A. Repealer. Any and all Ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies.
- B. Severability. **RESOLUTION 2024- ~~5~~ 4-**

**RESOLUTION OPPOSING THE STATE OF NEW JERSEY'S NEW PROPOSED  
SHORE PROTECTION RULE AND NJ PACT REGULATIONS**

**WHEREAS**, the State of New Jersey is proposing a new shore protection rule that would allow for the State Department of Environmental Protection (DEP) to restrict access to tidal waters and adjacent shorelines to protect threatened and endangered species of wildlife and their critical habitats; and

**WHEREAS**, while the City recognizes and understands the importance of the Department's service to protect critical habitat areas and endangered species throughout the State, for reasons including but not limited to public safety and recreational public access, the City has concern for the DEP's proposed new rule that would expand seasonal closures of beaches, tidal waterway, and beach entranceways during the high season in our shore town communities; and

**WHEREAS**, according to the State of New Jersey website, the DEP promotes public access and use of tidal waterways and their shores based on the common law of the Public Trust Doctrine, which provides for that public rights to tidal waterways and their shores and further establishes the right of the public to fully utilize these lands and waters for a variety of public activities; and

**WHEREAS**, in the DEP's stakeholder presentation on September 19<sup>th</sup>, 2023, that outlined the new proposed rule, there is a reference to a series of pictures to serve as examples of "injurious uses" that would trigger the restriction for access; and

**WHEREAS**, those references to "injurious uses" include pictures of footsteps on the beach, walking along the shoreline, shoreline access by boat, and accessing the beach with an unleashed dog; and

**WHEREAS**, expanding the DEP's ability to restrict access to the public and municipal public safety departments to our waterways seems to be in conflict with the Public Trust Doctrine that that the state bases all of their public access rules on; and

**WHEREAS**, with Brigantine #1 industry being tourism and our beaches being one of the main attractions for visitors to our City, restricting access to our public beaches may result in an adverse impact on the local economy; and

**WHEREAS**, according to the federal Department of Homeland Security's Emergency Response Plan, the actions taken in the initial minutes of an emergency are critical; and

**WHEREAS**, while the local shore communities and City do our best to support the needs for emergency water response during the peak summer season, due to the seasonality and coastal geographical location of our area in combination with coastal storms that cause rough water conditions, water rescues and sadly, sometimes fatal drownings are a common occurrence throughout our area; and

**WHEREAS**, if the State is to establish this new rule with no changes, the proposed restriction of access to local public safety departments including but not limited to Police, Fire Department, and Beach Patrols for the purposes of emergency response will put life and safety of the general public at risk; and

**WHEREAS**, historically, new rules issued by the NJDEP have been promulgated pursuant to legislation; and

**WHEREAS**, again in this case like the case with the State's proposed NJ PACT rules, there is no legislation that has authorized NJDEP to require more stringent requirements and restrictions on public lands; and

**NOW, THEREFORE, BE IT RESOLVED**, by the City Council of the City of Brigantine in the State of New Jersey, duly assembled in public session this \_\_\_\_ day of March 2024, as follows:

1. The preamble of this Resolution is incorporated here by reference and made a part hereof as the findings of the City Council.
2. The City of Brigantine hereby authorize a copy of this Resolution be submitted to Governor Phil Murphy, DEP Commissioner Shawn LaTourette, DCA Commissioner Jacquelyn Suarez, Senator Vince Polistina, Assemblyman Don Guardian, and Assemblywoman Claire Swift for their review and consideration in advance of release of the proposed new rule for public comment.
3. The City of Brigantine hereby further requests that the Legislature be encouraged to exercise its legislative oversight authority to review and approve the new proposed shore protection rule and the NJ PACT regulations prior to adoption that may have significant impacts on coastal communities statewide, so as to ensure the fairness and the maximum public acceptance of those new proposed regulations.

**WHEREAS**, the City of Brigantine needs new and upgraded Fire Department vehicle and;

**WHEREAS**, Hertrich Fleet Services can provide vehicles under NJ State Contract 21-Fleet-01483 and:

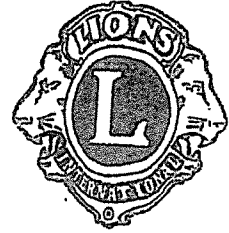

Thanks for your response to our Certificate of Insurance submittal, and for your past assistance with organizing and setting up Lions Club annual Car Show. Our previous chairperson, Frank Congemi, has decided to step back this year, though he is still involved as an advisor to the committee, which is now chaired by Lou Marchisani and myself. We have begun planning this year's show, and are writing to solicit your approval and assistance.

We have selected Sunday, June 9<sup>th</sup> for the show, and anticipate holding it in the parking area adjacent to the CER, as we have for the past several years. The hours of the show will be 10:00AM to 2:00PM. We typically start setting up at 8:00AM. The cars start arriving 8:30 – 9:00. The show will be open to classic cars from the past hundred years to the present. We will have them lined up in the parking spaces in the lot. Attendees will have the opportunity to vote on their favorite cars, and trophies will be awarded to the top few vote getters. We begin cleaning up at the close of the show, and are usually done by 3:00PM. Over the past few shows we have had 40 – 50 cars on display. We expect the same number this year, but it is hard to guesstimate so far in advance. We can provide a better count as we get closer to the event date. Since we do not charge admission, we do not have an precise count on attendees, but our estimate is that there are several hundred spread over the hours of the show. As you might expect, the heaviest crowd is there from 11:00 to 1:30.

We would like to request the assistance of the Department of Public Works as we have for past shows. We request that they supply traffic cones and garbage and recycle cans, which we will place around the area. We also request that the exterior bathrooms at the CER be open and available. After the show, we ask that the DPW return to pick up the trash and cones. We have had a brief meeting with Mr. John Doring and Jim Mogan a week or so to be complete the set-up plans. We have not required either police or crossing guards at any of our previous shows. We do expect to have several food trucks attend the show. The number is uncertain at this point. Let us know if there is anything further we need to do to accommodate them.

We will be working with other local organizations to hopefully have their mascots make an appearance at the show, at least for part of the day. This might include Briggys the Fox, the Polar Bear, the MMSC mascot, and the Brigantine Lion. We hope to have representatives from People and Puppies at Work for Sight along with Seeing Eye Dog trainee puppies. They were a great addition to the show last year.

We look forward to working with you on this project to make this a successful event. The Car Show is one of our big fundraising events of the year. We are working towards donating funds to The Seeing Eye for the purchase of another puppy. This will be our tenth one.
