CITY OF BRIGANTINE ORDINANCE 3 -2024

AN ORDINANCE TO AMEND CHAPTER 234 OF THE CODE OF THE CITY OF BRIGANTINE, ENTITLED "PARKING LOTS" TO UPDATE THE PARKING REGULATIONS IN CITY PARKING LOTS FOR PERMIT PARKING

WHEREAS, Chapter 234 of the Code of the City of Brigantine (the "City"), entitled "Parking Lots," governs the parking of vehicles on public and private property; and

WHEREAS, Article I of Chapter 234 governs the parking of vehicles in various municipal parking lots throughout the City; and

WHEREAS, N.J.S.A. 40:48-2.46 permits the governing body of every municipality to make and amend ordinances to regulate vehicular traffic and the parking of vehicles in parking places open to the public, including public streets; and

WHEREAS, the City Council of the City of Brigantine believes it is in the best interests of the City residents to make amendments to Chapter 234 to effectively provide for the electronic payment of parking privileges for daily and seasonal parking and for the enforcement of parking regulations in lieu of the placement of identification tags on vehicles in all of the public parking lots.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Brigantine in the County of Atlantic, State of New Jersey, that Chapter 234 of the Code of the City of Brigantine shall be amended and supplemented as follows (underlined text illustrates additions, strikethrough text illustrates deletions):

ARTICLE I. AMENDMENTS TO EXISTING SECTIONS OF CHAPTER 234, ARTICLE I, ENTITLED "MUNICIPAL PARKING LOTS."

§ 234-1 Registration and identification tag required. parking permit required.

- A. No person shall park any vehicle in any of the ocean front parking areas owned and maintained by the City of Brigantine for the time period beginning with the Friday of Memorial Day weekend and ending with the Monday of Labor Day weekend unless such vehicle is registered with and bears an identification tag issued by the City of Brigantine as hereinafter provided. such person obtains an electronic Daily or Seasonal Parking Permit for such vehicle. During the time period from Memorial Day weekend to Labor Day weekend when permit parking is required, no permit shall be necessary to park in ocean front municipal lots between the hours of 6:00 p.m. and 8:00 a.m.
- B. A Daily or Seasonal Parking Permit for parking in the municipal lots during the time period when permit parking is required can be secured upon arrival at a municipal lot using the pay-to-park Park MobileTM payment system. Once paid for, parking for the

registered vehicle shall be valid in all parking lots associated with the mobile-pay purchase and the license plate associated with that registered vehicle shall serve as the proof of payment for that vehicle for parking enforcement purposes.

- C. Payment for daily parking shall be made daily through use of the City's pay-to-park
 Park MobileTM payment system utilizing a mobile cellular device. Daily parking
 spaces cannot be reserved or paid for in advance. Payment for seasonal parking shall
 be made prior to the commencement of the Friday of Memorial Day weekend through
 use of same payment system utilizing a mobile cellular device.
- B. D. [Remains unchanged].
- C. E. [Remains unchanged].

- E. G. [Remains unchanged.]

ARTICLE II. Repealer, Severability, and Effective Date.

- A. Repealer. Any and all Ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies.
- B. Severability. In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable for any reason, then the City Council hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that it allows the City to meet the goals of the Ordinance.
- C. Effective Date. This Ordinance shall take effect upon proper passage in accordance with the law.

CITY OF BRIGANTINE ORDINANCE NO. 5 OF 2024

AN ORDINANCE AMENDING CHAPTER 210-37, ARTICLE II OF THE CODE OF THE CITY OF BRIGANTINE PORTION AS IT RELATES TO FEES

WHEREAS, the City of Brigantine is permitted by its police power to establish certain fees for services within the City of Brigantine; and

WHEREAS, the City of Brigantine is desirous of updating its fees schedule so that said fees are clearly stated in a way that will be more understandable to the general public; and

WHEREAS, the City Council of the City of Brigantine is desirous of amending said fee schedule.

NOW, THEREFORE, BE IT ORDAINED by the City of Council of the City of Brigantine in the County of Atlantic, State of New Jersey as follows:

SECTION I: Section 210-37 of the Code of the City of Brigantine shall be amended to read as follows:

CITY OF BRIGANTINE ORDINANCE <u>(</u>2-2024

AN ORDINANCE TO AMEND CHAPTER 260 OF THE CODE OF THE CITY OF BRIGANTINE, ENTITLED "STREETS AND SIDEWALKS" TO ADD ARTICLE II "REVOCABLE LICENSE AGREEMENTS FOR ENCROACHMENTS"

WHEREAS, a number of property owners, including residents and local businesses, have approached City Council to request a revocable license to allow said property owner to create or continue an existing encroachment upon municipal property; and

WHEREAS, the City of Brigantine (the "City") desires to provide a licensing process to allow property owners to obtain a revocable license, where such an encroachment is considered not to be a significant impairment to the City's use of the City property; and

WHEREAS, the encroachment will be removed at the sole cost and expense of the property owner should the Council determine, in its sole discretion, that such encroachment needs to be removed; and

WHEREAS, the City Council of the City of Brigantine believes it is in the best interest of the City residents to implement a checklist to be available to property owners in order to streamline the application process;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Brigantine in the County of Atlantic, State of New Jersey, that Chapter 260 is amended and supplemented to add Article II as follows:

ARTICLE I. Add Article II to Chapter 260 as follows:

Chapter 260

ARTICLE II: REVOCABLE LICENSE AGREEMENTS FOR ENCROACHMENTS

§ 260-9 Revocable Licenses.

A. The Council, in its sole discretion, may grant a property owner of the City of Brigantine a revocable license, in writing, allowing for said property owner to create or continue an existing encroachment upon municipal property where such an encroachment is considered by the governing body not to be a significant impairment to the City's use of the City property, and will be removed at the sole cost and expense of the property owner should the Council determine, in its sole discretion, that such encroachment needs to be removed in order for the City to make use of or enter upon said City property, subject to approval by the State of New Jersey in those cases, and in those cases only, where state approval is required either because of Green Acres funding of public property or other state requirements. A revocable license is not a substitute for a building permit or a construction permit when either is otherwise required by this Code.

- B. Any revocable license granted by the Council must be granted by resolution, be in a written form of agreement, approved by the City Solicitor and incorporate at least the following terms:
 - 1. An indemnification and hold harmless clause protecting the municipality against any loss, injury, damage, or claim arising out of the use of the City property encroached upon;
 - 2. A clause allowing for the termination of the revocable license upon notice of termination in the sole discretion of the Council and at the sole cost and expense of the property owner;
 - 3. A clause discussing enforceability in case the property owner fails to comply with the aforesaid license agreement, by allowing the City to remove said encroachment at the sole cost and expense of the property owner; and
 - 4. A term requiring the licensee to keep in place at all times personal injury liability insurance coverage, in the sum of at least \$100,000 (or other appropriate amount as required by the City), upon the owner's property and the encroachment or use, at the owner's sole cost, and ensuring that the City is named therein as an additional insured. The owner shall provide proof of such insurance coverage at the time of issuance of the license, and of the continuation of such coverage, on an annual basis, as required by the license or permit.
- C. All license agreements shall be recorded in the Clerk's office of Atlantic County at the sole cost and expense of the property owner as set forth in Subsection E.
- D. All license agreements shall be assignable to a new owner of the adjacent property served by the encroachment.
- E. The property owner shall pay to the City a one-time application fee in the amount of \$300.00 in cash or check issued to the City of Brigantine submitted with the application, along with a deposit into the City's escrow account in the amount of \$500 which shall be used to pay for all costs associated with the solicitor's preparation of the revocable license agreement and the filing fee with the Atlantic County Clerk's office. In the event the cost of preparation and filing fees are less than \$500, the remaining funds shall be returned to the property owner. In the event that the legal fees exceed \$500, along with the filing fees, same shall be the responsibility of the property owner which shall be paid prior to the filing of the license.

§ 260-10: Application; Contents.

An application for a revocable license shall be filed in a manner and on forms provided by the City Clerk's office. The application form shall, at a minimum, contain the following information in a clear and legible manner suitable for recordation:

- A. A legal description, prepared by a New Jersey professional licensed surveyor, of the adjoining property deriving the potential benefit of the encroachment;
- B. Other identifying information, including the property street address and block/lot of

- both the private and public property;
- C. A legal description, prepared by a licensed New Jersey professional surveyor, of the proposed encroachment both in the form of a narrative and supplemental drawings showing the type, nature, and extent of the encroachment;
- D. An acceptable current title report, excerpt or lot book report that establishes the legal ownership of the property in question;
- E. The identity and original, notarized signature(s) of the legal owner(s) of the adjoining property to be benefited as necessary to establish a legally binding agreement and covenant that shall run with the title of the land;
- F. Evidence that the requested encroachment cannot be reasonably accommodated on the applicant's own property and outside the City's right-of-way;
- G. Evidence that a hardship exists necessitating the encroachment and that the hardship was not created by the applicant or his/her agents;
- H. Any other information that, in the opinion of the City Clerk, code enforcement and/or the City Engineer is necessary to adequately evaluate the application, including, but not limited to, property line survey, topography, geotechnical reports, drainage studies and construction details of the proposed structure; and
- I. A nonrefundable application fee along with a check for all legal fees and filing fees as set forth more fully in § 260-9 of this chapter.

§ 260-11: Application; Procedure.

- A. Filing. An application for a revocable license into a planned or existing public right-of-way shall be filed by the owner of the property for which the revocable license is sought or by an authorized representative of the owner. Such application shall be made to the City Clerk and shall be on forms furnished by the City Clerk.
- B. Filing fee. A uniform fee, established by the Council under separate resolution, shall be required upon the filing and investigation of the application for revocable license or transfer of a revocable license to defray administrative costs incurred by the City in processing the application.
- C. Investigation. An investigation shall be conducted by all departments of the City having an interest in, or jurisdiction over, the matter. Upon the receipt of an application pursuant to the provisions of this article, the City Clerk shall transmit the application to all affected departments for written reports of findings and recommendations. All such written reports shall be submitted to the Director of Public Works for consideration when making a decision on the application.
- D. Criteria for evaluation and approval. A revocable license application may be approved when it can be reasonably demonstrated that the structure will not interfere with the present and prospective public use of a street or right-of-way and will generally conform to the following requirements:

- 1) It should be located in a manner that is not hazardous to the traveling public, including motorists, bicyclists and pedestrians;
- 2) It should be sufficiently set back from the edge of pavement or street center line to provide adequate travel, parking and walking lanes;
- 3) It should not conflict with preexisting public utility structures, especially hydrants, vault and service meters in any manner that necessitates relocation thereof at public expense or causes any other unacceptable interference, including impediments to the maintenance, relocation or repair of pipelines, conduits or substructures of any public utility;
- 4) It will not preclude public access, use or enjoyment of any area that has historically established such access, use or enjoyment;
- 5) It is not precedent-setting in nature to the extent that it creates a noticeable projection into the streetscape as established by existing construction and improvements on neighboring properties; and
- 6) It does not create structures of unusual or unacceptable appearance, form, shape or height that detract from the general quality of the streetscape.

§ 260-11: Licensee responsible for maintenance.

The licensee shall be solely responsible for the maintenance, repair, and upkeep of all structures and improvements, including landscaping, approved under a revocable license. Failure to maintain such facilities in good repair and to a reasonable prevailing standard, subject to the sole judgment of the City, may be sufficient cause for the City to order removal of such structure at the owner's expense upon 60 days' written notice.

§ 260-12: Licensee responsible for restoration.

Every licensee shall be responsible for restoring the site used pursuant to the license to its prior condition, upon the conclusion of said use or upon termination of the license, whichever occurs first. Any damage to the site or any trash, litter, or debris remaining on the site following said use shall be presumed to have been caused by the licensee, and, if the licensee fails to rebut said presumption or to repair the site or remove the materials, within five days of notice to do so, a charge may be levied upon the licensee, by the City, for the cost to remove the materials, plus an administrative surcharge of 25%.

§ 260-13: Violations and penalties.

A. Any person who violates any provision of this article shall, upon conviction thereof, be punished by a fine of not more than \$2,000. A separate offense shall be deemed committed on each day during or on which a new violation occurs or continues. The court, in its discretion, may order

the imposition of up to a maximum of 90 days of community service in addition to or as a substitute for any fine.

B. As an additional remedy, the construction or maintenance of any encroachment in violation of any provision of this chapter shall be deemed, and is declared to be, a public nuisance and may be subject to abatement summarily by a restraining order or injunction issued by a court of competent jurisdiction.

ARTICLE II. Repealer, Severability, and Effective Date.

- A. Repealer. Any and all Ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies.
- B. Severability. In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable for any reason, then the City Council hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that it allows the City to meet the goals of the Ordinance.
- C. Effective Date. This Ordinance shall take effect upon proper passage in accordance with the law.

AN ORDINANCE OF THE CITY OF BRIGANTINE AMENDING VARIOUS SECTIONS OF THE MUNICIPAL CODE CONCERNING THE POSSESSION OR CONSUMPTION OF ALCOHOLIC BEVERAGES

WHEREAS, the City Manager and City Solicitor have reviewed the municipal code and determined that updates are required concerning the possession or consumption of alcohol in public places; and

WHEREAS, the City Council reviewed the recommendations and seek to codify these amendments; and

NOW, THEREFORE, BE IT ORDAINED AND ENACTED, by the City Council of the City of Brigantine, County of Atlantic, State of New Jersey that the Brigantine City Code be and is hereby amended and supplemented with as detailed herein. (Amendments in Bold and Underline)

SECTION 1. Amendment to Chapter 91 of the City Code entitled "Alcoholic Beverages"

Section 91-4 of the City Code is amended and supplemented to read as follows:

§ 91-4 Consumption in public prohibited.

It is hereby prohibited to drink any intoxicating liquor on any sidewalk, street, avenue, highway, public parking lot, park, recreation area or in any vehicle not on private property within the City of Brigantine, Atlantic County, New Jersey, at any time without first applying for and obtaining a special events permit pursuant to the process established at §210-8 et seq. of this Code and a payment of a fee as established at §210-37 of the Code coupled with approval of a separate Special Events License approved by the New Jersey Division of Alcoholic Beverage Control if applicable.

SECTION 2. Amendment to Chapter 241 of the City Code entitled "Recreational Facilities"

Section 241-1 of the City Code is amended and supplemented to read as follows:

§ 241-1 Alcoholic beverages prohibited.

No individual will be allowed to consume alcoholic beverages on, in or about the various recreation facilities in the City of Brigantine. For the purposes of this section, anyone who possesses an open

container of alcoholic beverage will be considered to have consumed the same. This section shall not apply to the City Golf Course and clubhouse facilities.

SECTION 3. No amendments to alcohol on beach areas.

Nothing herein shall amend the prohibition of possessing or consuming alcoholic beverages on the City's beaches and such provisions shall continue in full force and effect.

SECTION 4. Repealer, Severability, and Effective Date.

- A. Repealer. Any and all Ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies.
- B. Severability. In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable for any reason, then the City Council hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that it allows the City to meet the goals of the Ordinance.
- C. Effective Date. This Ordinance shall take effect upon proper passage in accordance with the law.

LEASE AGREEMENT

THIS LEASE ("Lease") is made and entered into between City of Brigantine, a political subdivision of the State of New Jersey, referred to in this Lease as "Landlord", and Brigantine Rowing Rowing for the Disabled, Inc., a New Jersey non-profit corporation, referred to in this Lease as "Tenant".

Landlord is the owner of that certain land and improvements, known as 518 Bayshore Avenue, Brigantine, New Jersey 08203 and further identified at Block 6705, Lot 2.01 on the Tax Maps of the City of Brigantine ("Premises"). In consideration of the mutual covenants and agreements set forth in this Lease, and other good and valuable consideration, Landlord leases to Tenant the Premises.

ARTICLE I. TERM

1.01 <u>Term of Lease</u>. The term ("Term") of this Lease shall be for a perpetual commencing on April ___, 2024 (the "Commencement Date"), and ending on upon sixty (60) days' written notice by either Landlord or Tenant to the other party (the "Termination Date").

ARTICLE 2. RENT

- 2.01 <u>Rent</u>. During the Term, Tenant agrees to pay to Landlord monthly rent in the amount of One Thousand Five Hundred Dollars (\$1,500.00) ("Rent") for the Premises. The Rent shall be used towards Landlord's payment of all maintenance costs, cleaning and repair on the Premises.
- 2.02 <u>Taxes, Assessments and Expenses</u>. Except as set forth herein, Landlord shall be obligated hereunder to pay all costs and expenses incurred with respect to, and associated with, the Premises, including, without limitation, all taxes and assessments, utility charges, replacement and restoration expenses together with any and all other assessments, charges, costs and expenses of any kind or nature whatsoever related to, or associated with, the Premises. Notwithstanding the foregoing, Tenant shall be obligated hereunder to pay all costs related to bills from Comcast Corporation, including, but not limited to, television and internet service.

ARTICLE 3. USE OF PREMISES

- 3.01 <u>Permitted Use</u>. Tenant shall use the Premises as a boathouse.
- 3.02 <u>Waste, Nuisance or Illegal Uses</u>. Tenant shall not use, or permit the use of, the Premises in any manner resulting in waste of the Premises or constitutes a nuisance or violates any statute, ordinance, rule or regulation applicable to the premises or for any illegal purpose. The Tenant shall not use the Premises or permit them to be used in any manner that will cause a cancellation of, or exclusion to, any fire, liability or other insurance policies insuring the Premises or any improvements on the Premises, or insuring the Landlord for any liability in connection with the ownership of the Premises.

ARTICLE 4. REPAIRS AND MAINTENANCE

4.01 Repairs by Landlord. Landlord at its own expense and risk, shall be responsible for the maintenance and repair of the Premises, interior and exterior including, but not limited to, all equipment (including wiring), fixtures, fit-up and appliances now or hereafter located at or in the Premises. Same shall be maintained by Tenant in good and safe order, condition and appearance, and Tenant shall make all necessary and appropriate repairs, upgrades, replacements and renewals thereto. In the event of any damage to the Premises by Tenant, Landlord shall be permitted to seek reimbursement for all reasonable costs expensed towards the repair of such damage.

ARTICLE 5. ALTERATIONS, ADDITIONS AND IMPROVEMENTS

5.01 <u>Consent of Landlord</u>. Tenant shall not make any alterations, additions or improvements to the Premises without the prior written consent of Landlord. Consent for nonstructural alterations, additions, or improvements shall not be unreasonably withheld or unduly delayed by Landlord.

ARTICLE 6. INTENTIONALLY OMITTED

ARTICLE 7. INSURANCE AND INDEMNITY

- 7.01 <u>Liability Insurance</u>. Landlord and Tenant hereby acknowledge that Tenant is insured through Landlord's insurance. Notwithstanding the foregoing, Tenant, at its own expense, shall provide and maintain in force during the Term of this Lease comprehensive general liability insurance with a minimum combined single limit of liability, on an occurrence basis, in an amount of One Million Dollars (\$1,000,000), covering Landlord as well as Tenant, for any liability arising out of personal injury as a result of Tenant's rowing and related activities therewith. Tenant shall furnish Landlord with certificates of all insurance required by this paragraph. The policy shall contain a clause that the Tenant will not cancel or change the insurance without first giving the Landlord ten (10) days prior written notice.
- Indemnification by Tenant. Tenant covenants and agrees that it shall, at its own cost and 7.02 expense, indemnify, defend and save harmless Landlord against and from, and Landlord shall not be liable to Tenant for, any and all losses, costs, damages, expenses and liabilities, including without limitation reasonable attorneys' fees ("Losses") which may be incurred or paid out by or on behalf of any person arising in any manner whatsoever from, out of or in connection with (i) the use and occupancy of the Premises by Tenant, (ii) that certain License Agreement between Landlord, Tenant and Stockton University dated July 1, 2022 (the "License"), (iii) the breach of or failure to perform any of the terms or conditions of this Lease required to be performed by Tenant, (iv) any failure by Tenant to comply with any statutes, regulations, ordinances or orders of any governmental authority, (v) any work done in or to the Premises by or on behalf of Tenant, or (vi) any act, omission, or negligence on the part of Tenant and/or its officers, employees, agents, customers and/or invitees, and Tenant covenants and agrees it shall, at its own cost and expense, indemnify, defend and save harmless Landlord against and from, and Landlord shall not be liable to Tenant for, any and all Losses which may be incurred or paid out by or on behalf of any person arising in any manner whatsoever from, out of or in connection with any accident, damages, death, injury on or about the Premises, or the damage, loss or theft of property in or about the Premises (whether involving property belonging to Tenant or any other person), resulting from any cause whatsoever. Tenant covenants, upon notice from Landlord, to defend such action or proceeding by legal counsel reasonably satisfactory to Landlord. Tenant covenants, upon notice from Landlord, to defend such action or proceeding by legal counsel reasonably satisfactory to Landlord.
 - 7.03 Survival. The provisions of Section 7.01 and 7.02 shall survive termination of this Lease.

ARTICLE 8. DEFAULT

- 8.01 <u>Default by Tenant</u>. If Tenant allows the Rent to be in arrears more than thirty (30) days after written notice of that delinquency, or if Tenant remains in default under any other term or condition of this Lease for a period of thirty (30) days after written notice from Landlord and has failed to commence a cure of same, Landlord may at its sole option, without further notice to Tenant, terminate this Lease in which event the parties shall have no further rights and obligations to each other.
- 8.02 <u>Waiver of Breach</u>. A waiver by either Landlord or Tenant of a breach of this Lease by the other party does not constitute a continuing waiver or a waiver of any subsequent breach of the Lease.

ARTICLE 9. ASSIGNMENT AND SUBLETTING

9.01 No Assignment or Subletting Without Landlord Consent. Except for the License, Tenant may not assign, sublet, encumber, or otherwise transfer this Lease, or any right or interest in this Lease or in the Premises or the improvements on the Premises, without the written consent of Landlord. Landlord's consent to any assignment or sublease shall not be unreasonably withheld. The assignment or sublease of less than all of the Premises is prohibited.

ARTICLE 10. MISCELLANEOUS

- 10.01 <u>Condition of Premises</u>. Tenant will keep the leased property in a clean and wholesome condition and will comply at all times with all lawful health and police regulations.
- 10.02 <u>Parties Bound</u>. This Lease shall be binding upon, and inure to the benefit of, the parties to the Lease and their respective heirs, executors, administrators, legal representatives, successors, and assigns when permitted by this Agreement.
- 10.03 <u>Applicable Law</u>. This Lease shall be construed under and in accordance with, the laws of the State of New Jersey.
- 10.04 <u>Legal Construction</u>. In case any one or more of the provisions contained in this Lease shall for any reason be held by a court of competent jurisdiction to be invalid, illegal, or unenforceable in any respect, such invalidity, illegality, or unenforceability shall not affect any other provision of the Lease, and this Lease shall be construed as if the invalid, illegal, or unenforceable provision had never been included in this Lease.
- 10.05 <u>Amendment</u>. No amendment, modification, or alteration of the terms of this Lease shall be binding unless it is in writing, dated subsequent to the date of this Lease, and duly executed by the parties to this Lease.
- 10.06 Attorneys' Fees and Costs. If, as a result of a breach of this Lease by either party, the other party employs an attorney or attorneys to enforce its rights under this Lease, then the breaching or defaulting party agrees to pay the other party the reasonable attorneys' fees and costs incurred to enforce this Lease.
- 10.07 <u>Force Majeure</u>. Except with respect to Tenant's obligation to pay Rent, hereunder, neither Landlord nor Tenant shall be required to perform any term, condition, or covenant in this Lease so long as such performance is delayed or prevented by force majeure, which shall mean acts of God, strikes, lockouts, material or labor restrictions by any governmental authority, civil riot, floods, acts of war,

terrorism, bioterrorism, and any other cause not reasonably within the control of Landlord or Tenant and which by the exercise of due diligence Landlord or Tenant is unable, wholly or in part, to prevent or overcome.
