# RESOLUTION AUTHORIZING FIRST AMENDMENT TO SITE ACCESS AGREEMENT

**WHEREAS**, the City of Brigantine is the owner of the property known as Block 2901, Lot 5 on the Tax Maps of the City of Brigantine ("**Property**"); and which is more commonly known as the Civic Center property located at 100 31<sup>st</sup> Street South; and

WHEREAS, Volunteers of America Delaware Valley Property, Inc. (VOADV) is purchasing the property for use as part of the City's Third Round affordable housing obligation; and

WHEREAS, on February 2, 2022, the Parties entered into the Access Agreement, which granted VOA the ability to access the Premises for the purpose of undertaking due diligence related to the environmental conditions of the Premises; and

WHEREAS, on February 15, 2023, the Parties entered into a Municipally Sponsored Affordable Housing Agreement (the "Purchase Agreement"), under which VOA agreed to purchase the Premises from the City; and

WHEREAS, in order to develop the site, VOADV needs to perform certain due diligence where it will be necessary for employees, representatives, professionals and agents of VOADV to access the property; and

**WHEREAS**, the City is willing to grant VOADV a right of access to the Property to perform such due diligence pursuant to the terms and conditions contained in the First Amendment to the Site Access Agreement attached hereto.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Brigantine, County of Atlantic, State of New Jersey that the City shall enter into and authorize the execution of a First Amendment to Site Access Agreement with VOADV, according to the terms and conditions substantially similar to those contained in the First Amendment to Site Access Agreement attached hereto. Wherein, VOADV shall have a right of access to the property known as Block 2901, Lot 5 on the Tax Maps of the City of Brigantine for the purpose of performing due diligence.

# FIRST AMENDMENT TO SITE ACCESS AGREEMENT

THIS FIRST AMENDMENT (the "Amendment") to the Site Access Agreement (the "Access Agreement") is entered into on this \_\_\_\_\_\_\_ day of \_\_\_\_\_\_\_, 2023, by and among VOADV PROPERTY, INC., a New Jersey not-for-profit corporation, having a business address of 531 Market Street, Camden, NJ 08102 ("VOA" or "Grantee") and THE CITY OF BRIGANTINE, a New Jersey municipal corporation with a principal address of 1417 West Brigantine Avenue, Brigantine, NJ 08203 ("Brigantine" or "Grantor"). The Grantor and Grantee collectively shall be referred to as the "Parties".

### RECITALS

WHEREAS, on February 2, 2022, the Parties entered into the Access Agreement, which granted VOA the ability to access the Premises for the purpose of undertaking due diligence related to the environmental conditions of the Premises;

WHEREAS, Section 1 of the Access Agreement granted the Grantee Entities a revocable license to enter upon the Premises to perform the Work on the Premises;

WHEREAS, VOA is still in the process of conducting the Work on the Premises;

WHEREAS, on February 15, 2023, the Parties entered into that certain Municipally Sponsored Affordable Housing Agreement (the "Purchase Agreement"), under which VOA agreed to purchase the Premises from Grantor;

WHEREAS, pursuant to Section 5.1 of the Purchase Agreement, VOA has a period of sixty (60) days from the Effective Date, as may be tolled by Section 21(g) of the Purchase Agreement (the "Due Diligence Period") to complete its due diligence investigation, inspections and analysis with regard to the Premises, including, but not limited to physical inspection of the property related to the foundation, roof, structural, wiring, electrical, plumbing, heating, air-conditioning and mechanical, topography, ecological studies, geotech investigations, soils tests, samplings, cultural studies, and other engineering tests, and terminate and pest inspection (the "Due Diligence Inspections");

WHEREAS, under Section 5.1.4. of the Purchase Agreement, VOA shall have the right to access the Premises to conduct its due diligence during the Due Diligence Period;

WHEREAS, the Parties have agreed to expand the scope of the revocable license to include the Due Diligence Inspections during the Due Diligence Period; and

WHEREAS, the Parties desire to amend the Access Agreement to expand the scope of the revocable license to include the Due Diligence Inspections and limit the term of the Access Agreement to the Due Diligence Period.

NOW, THEREFORE, in consideration of the covenants and agreements herein contained and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Member and the Company hereby agree as follows:

- 1. <u>Grant of Access and Scope of Work.</u> Section 1 of the Access Agreement is hereby amended to expand the scope of the revocable license to permit the Grantee Entities the ability to complete the Due Diligence Inspections.
- 2. <u>Term.</u> Section 4 of the Access Agreement is hereby deleted in its entirety and replaced with the following:
  - 4. <u>Term.</u> The Grantor's and Grantee's obligations under this Agreement shall be in effect as of the date of full execution of this Agreement and will terminate immediately upon the expiration of the Due Diligence Period. Grantee and Grantee Entities shall conduct and complete the Due Diligence Inspections and the Work during the term of this Agreement. The expiration of the revocable license under this Section 4 shall only be amended upon the prior written consent of the Parties.
- 3. <u>Insurance.</u> Section 9 of the Access Agreement shall be amended to delete the first sentence beginning with "Throughout the term of this Agreement, . . ." and replaced with the following: "Throughout the term of this Agreement, Grantee shall cause Grantee Entities to obtain and maintain, with an insurance company or insurance companies reasonably satisfactory to Grantor, a policy of commercial general public liability insurance and/or property damage, with a broad contractual liability endorsement covering the Due Diligence Inspections and the Work, with a combined single limit of not less than \$1,000,000.00 per occurrence for bodily injury and property insurance. Grantor shall be named as an additional insured under the coverages described in this Section 9. Grantee shall ensure that Grantor is provided a certificate of insurance by each entity accessing the Premises pursuant to this Agreement."
- 4. <u>Due Diligence Inspections</u>. Each of Sections 2, 3, 5, 7, 9, 10 and 17 are hereby amended to incorporate the Due Diligence Inspections together with any references to the Work.
- 5. <u>Agreement Otherwise Unchanged</u>. Except as set forth in this Amendment, the Access Agreement remains unchanged and in full force and effect.
- 6. Governing Law. This Amendment shall be governed by, and construed in accordance with, the laws of the State of New Jersey (without regard to any conflicts of law principles that would require the application of the laws of any other jurisdiction).
- 7. <u>Counterparts</u>. For the convenience of the parties hereto, this Amendment may be executed in one or more counterparts, each of which shall be deemed to be an original but all of which together shall constitute one and the same instrument. Executed signature pages to this Amendment may be delivered by email, PDF, or other electronic transmission and any such signature page shall be deemed an original.

# RESOLUTION AUTHORIZING AWARD OF EMERGENCY CONTRACT FOR FOOD AND BEVERAGE SERVICES AT THE BRIGANTINE LINKS GOLF COURSE UNDER SECTION 6 OF THE LOCAL PUBLIC CONTRACTS LAW

WHEREAS, the City is in the process of seeking proposals from vendors to provide food and beverage services at the Brigantine Links Golf Course through the Competitive Contracting Process pursuant to the Local Public Contracts Law at N.J.S.A. 40A:11-4.1 et seq.; and

WHEREAS, the Brigantine Links Golf Course is currently under contract with multiple private parties for events and banquets in April, May, and June that require food and beverage services; and

WHEREAS, the City understands that it is highly unlikely, if not impossible, to award a vendor through the Competitive Contracting Process that would be able to transition into the space and obtain the necessary permits required by the Division of Alcoholic Beverage Control within the timeframe required for the scheduled events; and

**WHEREAS**, the City will be at risk for potential litigation if forced to cancel the events and the Brigantine Links Golf Course will suffer adverse consequences; and

WHEREAS, N.J.S.A. 40A:11-6 authorizes any contract to be negotiated or awarded "without public advertising for bids and bidding therefore, notwithstanding that the contract price will exceed the bid threshold, when an emergency effecting the public health, safety or welfare requires the immediate delivery of goods or the performance of services", provided that the awarding of such contracts is made in the manner set forth in said statute, one of which requirements is that "the official in charge of the agency wherein the emergency occurred, or such other officer or employee as may be authorized to act in place of that official, shall notify the Purchasing Agent, a supervisor of the Purchasing Agent, or a designated representative of the governing body, as may be appropriate to the form of government, of the need for the performance of a contract, the nature of the emergency, the time of its occurrence and the need for invoking this section; [and] if that person is satisfied that an emergency exists, that person shall be authorized to award a contract or contracts for such purposes as may be necessary to respond to the emergent needs, [which] notification shall be reduced to writing and filed with the Purchasing Agent as soon as practicable"; and

**NOW, THEREFORE, BE IT RESOLVED,** by the City Council of the City of Brigantine, County of Atlantic, State of New Jersey that

- 1. The City Council hereby declares that a lapse in service that would result from waiting to award a contract to a vendor through the Competitive Contracting Process is an emergency under N.J.S.A. 40A:11-6 in that it affects the public welfare and requires the immediate performance of services.
- 2. The Acting City Manager and the City's Purchasing Agent, in consultation with the Mayor and the applicable City Committee Liaison(s), is hereby authorized to enter into a temporary contract with the current vendor of the Brigantine Links Golf Course to avoid lapses in services and/or undertake such other actions as are necessary, without resort to public bidding, where time does not otherwise permit compliance with the bidding requirements of the Local Public Contracts Law, and upon the furnishing of such goods or services, the contractor furnishing such goods or services shall be entitled to be paid therefore and the City shall be obligated for said payment.
- 3. The term of this temporary contract shall be from this date through October 31, 2023.


