**Bond Ordinance Providing for Various Capital Improvements in and by the City of  
Brigantine, in the County of Atlantic, New Jersey, Appropriating \$17,300,875 Therefor and  
Authorizing the Issuance of \$16,435,831 Bonds or Notes of the City to Finance Part of the  
Cost Thereof.**

- Mayor Sera stated that Ordinance No. 22 includes funding for a new clubhouse at the Links Golf Course. The current clubhouse will remain in use until the new one opens, after which it will be demolished and the site restored to open space.
- Mayor Sera opened the public hearing.

- Dr. Michael Coates, 218 5<sup>th</sup> St No supports Mr. Garrison protect for the storms and emphasized storm protection.

## **COUNCIL MANAGER / COMMITTEE DISCUSSION**

- Tige Platt highlighted the food truck festival and the move to Hannaman Park
- Deputy Mayor Bew reported that the Brigantine Softball Wiffle Home Run Derby drew a strong turnout from both residents and visitors. She thanked the Public Works and Recreation Departments for mini golf a success.
- Councilman Haney reported a well-attended meeting at the Third and Fourth Ward. Congratulates Putt Putt Paradise on the opening. Congratulated Trevor Cohen and family on the MLB draft.
- Councilman Kane noted the success of the recent putt-putt event and praised the ongoing Brigantine cleanup efforts. Moorings meeting went well.
- Councilman Riordan thanked residents for attending and expressed appreciation for the community's continued engagement. Economic committee and cultural arts committee are moving forward.
- Mayor Sera thanked John Doring and recreational staff on mini golf. Inquired about Boat Ramp is closure.
- John Doring said he hoped by Friday, dependent on the tide
- Mayor Sera urged residents to check the City's website for safety updates and reminded everyone to stay out of the water until lifeguards confirm conditions are safe due to dangerous rip currents. Mayor Sera noted that the City is working with the DEP under CAFRA jurisdiction on the bulkhead extension. While progress is stalled, the City continues to support the project and advocate for residents. He clarified that the promenade is under county control, with work expected next year. Bulkhead improvements are underway in other areas.

## **PUBLIC COMMENTS**

- Frank Congemi, 605 West Shore Drive concerned with beach erosion.
- Mayor Sera explained more erosion is happening with added nor'easters every year. Noted the freeze on beach front erosion funds at federal level. Federal Government is looking into ways to slow erosion.
- Ann Phillips 405 27<sup>th</sup> Street thanks council for going to meetings requested. Requested increased enforcement of speeding violations.
- Mayor Sera acknowledged speeding concerns and clarified that enforcement is at the discretion of police officers under state statute. A traffic detail is active.

- Brooks Garrison thanked council for meeting at the Golf Course. Discussed the jurisdiction oversight of the Seawall.
- Mayor Sera emphasized the need to work with mandatory outside agencies to move the project forward.
- Councilman Riordan mentioned the extended timeframes involved when coordinating with outside agencies.
- Deputy Mayor Bew added that she has observed officers actively issuing tickets and confirmed that enforcement has been underway.
